Local Environmental Groups Applaud Dane County Zoning Decision on Enbridge Permit

MADISON: Local environmental groups were thrilled when the Dane County Zoning and Land Regulation Committee approved a Conditional Use Permit with a requirement for Environmental Impairment Liability insurance on the Enbridge Line 61 Waterloo/Marshall pump station. This permit was the last permit needed for Enbridge to expand Line 61 to an unprecedented 1.2 million barrels per day. The vote was unanimous.

Elizabeth Ward, Conservation Programs Coordinator of the Sierra Club-John Muir Chapter stated, "We are so happy to see the Dane County Zoning and Land Regulation Committee stand up for the concerned communities near the pumping station. Given the Department of Natural Resources' decision not to conduct a full Environmental Impact Statement, we're happy to see the in-depth analysis the Zoning Committee undertook. This decision shows that the committee recognized the threats posed by a potential tar sands spill and acted accordingly to protect our natural resources."

Unfortunately, the world learned about the significant damage a pipeline disaster can cause in 2010 with the Kalamazoo tar sands spill. The clean-up of that spill has exceeded \$1.2 billion and continues 4.5 years later. Mary Beth Elliott of 350 Madison said, "The Dane County Zoning and Land Regulation Committee did their duty and diligently listened to their constituents. Enbridge's record demonstrates their clean-ups are half-hearted, incomplete, and prolonged. The Environmental Protection Agency had to continually insist that Enbridge finish the Kalamazoo clean-up, while Enbridge resisted every step of the way."

Lori Van Caster, a resident in Marshall, located near the pumping station said, "Though many of us are still concerned about the risks this pipeline poses to our community, we are pleased to see that if a spill does occur there won't be years of uncertainty over when and if a clean-up will occur."
