Climate justice is an important aspect of climate change activism and the impacts of climate change are being felt disproportionately by BIPOC communities in a number of ways, most notably through: The unfair location of pollution-generating fossil fuel power plants that cause adverse health effects on surrounding neighborhoods and the impacts of climate change-caused extreme weather events. 350 Madison leaders realize that locally, nationally, and globally we only have a short time to take action to reduce human-caused climate change, and we can't slow down.

Monthly Meeting Co-Planner or Co-Host -



Enbridge withdraws its PSC permit application

Earlier this month, Canadian oil pipeline company Enbridge finally managed to obtain easements for a complete reroute of their



crude oil pipeline Line 5 around the Bad River Reservation. On Aug. 7, Enbridge wrote to the Public Service Commission withdrawing their application for a permit which would have given them the authority to use eminent domain. This means that the group of five advocacy organizations including 350 Madison, and the 32 landowners along the reroute who had applied to be intervenors have lost their chance to make their arguments against the pipeline and against eminent domain for private gain.

Still, the fight continues.

The Department of Natural Resources process is far from complete, and we will have many more opportunities to register our opposition to permits for this extremely dangerous pipeline, which threatens Copper Falls State Park, the Kakagon Sloughs, indigenous sovereignty, and the Great Lakes. We also have many opportunities to educate Gov. Tony Evers about the disastrous consequences that would result from extending the life of this 67-year-old piece of antiquated technology.

This summer I worked on coordinating 350 Madison's engagement in state policy making efforts, researched energy benchmarking and net-zero building, helped to create a distribution strategy for our new recruitment posters, and conducted information-gathering interviews as a member of the Energy Benchmarking and PC3 groups within the Community Climate Solutions Team.

As an intern, I learned the basic steps needed to get grassroots-level action started, such as strategy planning, collecting information, and how to ask people to join projects. I had the opportunity to experience state- and community- level government in action when I attended public hearings, and learned about Wisconsin-specific climate issues, such as oil

pipelines, pollution from coal plants, and major flooding.

Voter outreach with college-aged students and young adults

As classes start back up in Madison, we're working to organize and connect with students and young adults. Recently, we submitted a grant to Clean and Prosperous America for funding a central coordinator that administers student-focused, "climate-aware" Get Out the Vote messaging and outreach, as well as funding for six or more regional coordinators around the state. Additionally, we are developing points of contact for as many UW System campuses and Wisconsin Technical College System campuses as possible, as part of our work to identify leaders of existing faculty, student degree programs and studentled groups that are already active in environmental studies, sustainability, and natural resource conservation. Finally, we are working to develop short messages for a series of "climate-aware" GOTV messages that will be completed, recorded and shared by youth and students.

As we continue to conduct voter education and generate volunteer support and enthusiasm, we'll also be working on messaging that highlights the connections between climate change and racial justice, and what's at stake in the federal and state elections around climate change.
