Pipeline resistance works!

On July 5 and 6, we saw our strategy on defeating pipelines affirmed. In those two days, three pipeline projects suffered heavy blows, and behind these events was our national movement led by both grassroots groups and national environmental organizations.

In a nutshell, our movement's strategy is to educate, mobilize, litigate, and cut off funding to the fossil fuel industry. We use many different tactics to reach and educate people where they are. Speaking to the many reasons most appealing to them, we mobilize people to participate in creative and bold actions, use lawyers to litigate in the courts, and participate in campaigns such as Stopthe Money Pipeline to drive investors away from fossil fuel infrastructure projects.

Amazing turnout to DNR's Line 5 hearing

In last month's newsletter, we asked you to show the Department of Natural Resources that you oppose Enbridge's Line 5 Reroute, and you responded magnificently! According to the DNR, more than 500 people tuned in to the virtual hearing on July 1. 79 people testified from the Ashland area to Dane County and beyond, with 92.4% emphatically opposed to granting the wetland and waterways permits. PSC fails to address climate change in draft Energy Assessment

The PSC is preparing its biennial Strategic Energy Assessment (SEA), which lays out plans for Wisconsin's energy future. Climate advocates have criticized the plan as "myopic," saying that it lacks bold action on clean energy and largely ignores several key areas such as net zero buildings, decentralized grids, and third party financing of solar installations. Shockingly, the SEA fails to mention climate change!
