## **Urge Senator Baldwin to Support the Bad River Band**

On December 12, 2023, the U.S. Court of Appeals for the 7th Circuit requested the United States submit its views in the Bad River Band v Enbridge case - <u>one that involves Tribal</u> sovereignty, Tribal treaty rights, the protection of our Nation's precious waterways, and the transition away from a fossil fuel economy. More than two months later and after the oral arguments in Chicago, on March 8, 2024, the U.S. Department of Justice confirmed with the 7th Circuit Court of Appeals that it intends to file a relevant amicus brief no later than April 8, 2024.

This means that the U.S. Government will be weighing in on the case, sharing its views, and ultimately, showing favor toward one side or the other. While there are many reasons to be hopeful that this will be a positive outcome, there is still much to be done. *Our Senators*, *including Tammy Baldwin, need to hear more from constituents regarding Line 5.* 

Let's come together and make this happen!

## Public Screening of "Common Ground" at First Unitarian Society, April 27

First Unitarian Society of Madison is celebrating <u>Faith Climate Action Week</u> by hosting a free screening of "Common Ground" on Saturday, April 27 at 7:00 PM. Doors will open at 6:30 for dessert, beverages and fellowship; a facilitated discussion will follow the film. ## **Evers Vetoes "CAFO Friendly"** Bill

We got a big (and fast!) win heading into Easter weekend: Governor Evers vetoed the socalled "Protect our Farms Act." This bill, AB957, would have "protected" factory farms (a.k.a. "CAFOs," Confined Animal Feedlot Operations) from local regulation, while enabling continuing harm to rural communities and the climate. CAFOs are a <u>main source of agricultural</u> <u>GHG and phosphorus emissions</u>, and of <u>elevated levels of toxic nitrates and</u> <u>manure-borne diseases</u> for nearby communities.


AB957 would have made it illegal for local governments to pass regulations on CAFOs that are stricter than the State's, taking away one of their last tools for saying "no" to CAFOs in their communities. One of 350 Wisconsin's partners, the **Sustain Rural Wisconsin Network** (SRWN) alerted us that this bill was going to Evers' desk in less than a week! Despite this quick turnaround, 350 and SRWN's other partners sent Evers over 600 comments, and he vetoed the Bill on Friday, March 29!

That the Bill passed the legislature is disappointing, a point we should make in the run-up to the November elections. Meanwhile, we celebrate the nimble, lively coalition that helped make this veto happen!



## Bipartisan Support for EV Chargers in Wisconsin Legislature

On March 12 the Wisconsin Senate passed <u>Senate Bills 791 and 792</u>, allowing private entities to own and operate electric vehicle (EV) charging stations, and charge customers by the amount of electricity used, rather than by how long they charge. This will allow the state to get \$78 million from the Federal Government,

### Meeting Recap: Ecoanxiety, Climate Grief, Solastagia

The monthly meeting in March was one of our best public meetings, according to several of the 80 people attending. Dakila Chungyalpa, founder and director of the Loka Initiative at the Center for Healthy Minds, explained why cultivating inner resilience is a form of environmental activism. After sharing her personal history with climate anxiety, she suggested some contemplative practices that can be helpful, including forest bathing, land based healing, somatics, mindfulness (broadly defined), tonglen meditation, writing or reciting a prayer, contemplative prayer, committing to individual behavior change, and committing to community-based action.
